Affiliate Agreement for Consulting Services

This Affiliate Agreement (“Agreement”) is made on this day of January 2022 between (Agent, Broker, Investor) (Affiliate) and The Denson EL Group, Inc (The Denson EL Financial Group, etc) hereinafter referred to as (“Company”).

WHEREAS, the Affiliate hereby wishes to engage in Company’s online program as provided in this Agreement. This Agreement has been entered into effect in the State of Delaware and shall be governed by, construed, and enforced in accordance with the laws of Delaware. By utilizing our services to this agreement and consent to being subject to the laws of Delaware regarding your physical location. **THEREFORE IN CONSIDERATION THEREOF**, all parties herein hereby agree to the terms and conditions set forth below:

1. Company Services. Company Services are described as follows; managing client files, documentation, processing, billing, contact via phone and/or electronic means as well as any other tasks that are deemed necessary.

2. Performance of Work. Company shall be solely liable for the performance of the requested services. The Company reserves the right to monitor Affiliate’s performance so as to verify that the Affiliate is performing its obligations in accordance with the terms and conditions herein. Company may ask, from time-to-time, Affiliate to provide records and documentation regarding Affiliate’s performance.

3. Term. This agreement shall commence on the this day of January 2022 and shall continue for a period of ten year(s).

4. Commissions. Company's commission will be based on a certain percentage per sale (funds received from client). Company will be compensated a total of 3% for processing of Affiliate's clients total sale with the remaining going to Affiliate. Affiliate will be paid 1.5% on a 5% client agreement and will increase to 2.0% after 3 successfully funded referrals, and 2.5% after 10 successfully funded referrals. This compensation structure can and will be amended upon agreement of both parties and upon the successful funding of 10 referrals. Affiliate understands that company will collect all fees. Pay days are within 72 hours of receiving funds from clients.

5. Company reserves the right to amend this agreement as needed from time to time and Affiliate agrees that all such amendments will apply to Affiliate, this includes any amendments to compensation structure modifications. Company will give affiliate 30 days notice.

6. NON-COMPETE COVENANT. For a period of 5 Years after the effective date of this Agreement, Affiliate will not directly or indirectly engage in any business that competes with Iconic Enterprises, Inc or lenders. This included personal loans (cash to clients) and personal lines of credits. Directly or indirectly engaging in any competitive business includes, but is not limited to: (i) engaging in a business as owner, partner, or agent, (ii) becoming an employee of any third party that is engaged in such business, (iii) becoming interested directly or indirectly in any such business, or (iv) soliciting any customer or partners of Iconic Enterprises, Inc for the benefit of a third party that is engaged in such business.
